194) Gina Sarazen

Transfer Station Attendant Rick Lamoy confided in councilmember Gina Sarazen regarding a resident refusing to pay more than \$5.00 for their dump fee. Rick says this resident is coming with 5-7 kitchen sized garbage bags. Highway Superintendent Jay Rust stated "while the fee is \$4.00 per bag, Rick has the discretion to charge people accordingly." The Town Board is also in agreement that Rick can be flexible per situation. Highway Superintendent Jay Rust will relay this information to Rick.

195) Highway

Highway Superintendent Jay Rust reported that paving in Conifer has been completed. The highway crew has done work on the Gull Pond Rd and Setting Pole Dam Rd. A new culvert was installed on the Gull Pond Rd November 8th. Culverts are being checked daily to make sure they are properly working before winter. Jay has applied for \$96,784.69 in CHIPS reimbursement which is scheduled to be paid on December 6th. Town Supervisor Joe Denis asked Jay if the Town of Piercefield owns the Setting Pole Dam Rd or if it is owned by Tupper Lake. To Jays knowledge there was a deal made before he took over as Highway Superintendent. Jay believes the agreement was Tupper Lake would plow Route 421 and in exchange Piercefield would maintain and receive CHIPS money for the Setting Pole Dam Rd. Since maintaining Setting Pole Dam was past practice Jay has continued to do so. Piercefield Town Clerk has no concrete documents supporting this agreement. Town Supervisor Joe Denis will contact Town Attorney Kirk Gagnier to verify the legalities of this transaction.

196) Code Officer Report

The Town Clerk created a document for Code Enforcement Officer Nicholas Snyder to fill out every month in lieu of his written report.
